PROGRAM OUTCOMES

EDUCATION

School-based Mentoring: Our results for 2019 were that 71% of youth in the School-based program who completed baseline and follow-up Youth Outcomes Surveys reported improvement in at least two of the outcome areas, exceeding our goal for this program, further demonstrating the impact the School-based Mentoring program has on at-risk youth. The outcome areas reported were Scholastic Competency, Social acceptance and Improvement in grades.

Paper City Mentoring: Our program serves teenagers grades 8-12, both male and female. We do not specifically seek out students of any demographic beyond that (school performance, attendance, etc.), but take referrals from parents, school counselors, and students. We served 20 students in 2017 and will project 30 students in the program by the end of 2018 (6 have graduated from the program).

United Way's Dolly Parton's Imagination Library: Provided 15,204 books to 1372 of 4624 possible children. Hosted two events reaching 404 individuals. KRA results from 5 elementary schools- 76% of DPIL reading On Grade Level compared to 48 % of all children in those 5 schools. 92% had increased interest in reading; 92% increased reading to child; 76% found DPIL tips helpful; 90% said program taught the importance of reading.

United Way's Map Your Future Program: Program in four area schools, Chillicothe, Unioto, Adena Health System, and Huntington. Outcomes will measure number of 6-year plans developed by students planning careers and college, increase in grades and behavior for participating students, increase in volunteer hours, increase in knowledge for parents and students.

United Way's Success By 6 Kindergarten Readiness: Program was in all 7 Ross County Schools, a four-week program that helps prepare incoming students to be ready both academically and socially. Students showed an average of 16-point increases in testing after participating in the program. 13% emerging readiness, 51% are approaching

Carver's Preschool, After School and Summer Programs:

Preschool—21 children served. 85% improved Kindergarten Readiness checklist After School—51 children served. 42% of 3rd graders passed the 3rd grade reading test. 84% of students improved on pretesting scores. 100% improved grades over the course of the school year. Summer-29 children served. 72% improved on pretest math scores; 72% improved pretest reading scores; 100% improved behavior.

Easter Seals Discovery Garden: 863 individual children, parents, grandparents, and caregivers/relatives took part in this program. 92% increase knowledge of parenting skills and resources to help prepare their child for school. 90% of children increased school readiness. 90% of children were on track in terms of literacy, social, emotional, and intellectual skills.

The Buck Fifty MADE Program: 2,266 students registered. 10% increase student participation in program, 82% improved their employment. 74% became more vocal for what they stand for. 71% felt parents were proud of them for being in the program.

School-Based Mentoring

Paper City Mentoring Our program serves teenagers grades 8-12, both male and female. We served 20 students in 2017 and will project 30 students in the program by the end of 2018 (6 have graduated from the program).

WeeCare Baby Steps 10 pregnant/parenting moms & dads. 94 classes/ or mentoring. 92% graduation rate. No dropouts.

HEALTH

United Way's Hunger Coalition Produce Giveaways: Distributed over 328 tons (757,000 lbs.) of food to over 4085 households (17,260 individuals).

Increased access to healthy food/produce for 100% of participants.

United Way's Hunger Coalition's Mighty Active Pack Club: Started in September and served 162 elementary students. 100% of students said they could focus better and do better in school and at home when they were not hungry. Teacher and parent surveys measuring outcomes collected in 2019.

Big Brothers Big Sisters Traditional Matching and Waitlist Services: Traditional Matching – 20 children and 16 adults participated. 93.3% of children improved in one area (academics, behavior, social acceptance, trust); 80% showed increase in three areas; and 46.7% showed an increase in all 4 areas.

Waitlist Services— 54 children served. Survey results: 37% improved socially and mentally due to program services based on staff evaluations. 12 events were offered to these children.

Child Protection Agency Abuse Assessments: 169 Abuse Assessments of Ross County children. 150 had medical exams. 1600 hours of counseling services. 23 parents received counseling service also.

Hope Clinic: 378 patients received medical, 208 received dental, 104 received vision. Mobile Market served 10,000 individuals. 100% have access to physical, dental, and mental health care and education.

OSU Cooking Matters Program: 5 Cooking classes for Adults, Cooking Matters for families, Cooking Matters for teens. 41 classes were held. 47% increase in participants choosing low-sodium options, 44% increase in participants choosing low fat or fat-free dairy products, 36% increase in participants using nutrition facts on food labels, 31% increase making homemade meals, 23% increase cooking healthy food.

Coalition Against Domestic Violence Phoenix House- Served 29 women and 26 children in 2018. 1265 bed nights, average stay 23 nights per person. 100% clients had a safety plan

CARES of Ross County- 391 support group participants; 54 support groups. Resource room has 5 computers and local agency brochures for clients, Substance use education classes are available.

YMCA Water Safety- 141 students served from Unioto, Bishop Flaget, Ross County Christian and preschool.

The Buck Fifty - MADE Program - 2050 participants. DFCA holds 5 random drug tests on 5% of the members throughout the school year.

Carver Community Center—Daily Meals- 1847 clients served. 79% of our clients received additional assistance through referrals, monthly health fairs or information sessions. 65% of our clients attend a monthly fair. 79% increased knowledge of services provided throughout the community.

2019 PROGRAM OUTCOMES

INCOME

Seeds of Hope We served 44 children, 80 Adults with 748 volunteer hours, and 4,539 bed nights provided. This year in 2019, I only have figures through the end of June (1/2 year), 14 children, 33 adults, 151 volunteer hours, 1,852 bed nights so far. These are the total outcomes of clients served. We always run between 60-70% with Income added or increased.

Men's Shelter All men residing at the shelter were referred to the Rapid Rehousing Program to verify eligibility, and if found eligible, housing assistance was provided. 2018 Program Results # of unduplicated men - 112 # of bed nights - 2314 2019 Program Results - As of September 30 # of unduplicated men - 78 # of bed nights - 1469

Frankfort Senior Center Our group numbered from 15 to 20 throughout the year. They were given access to healthy foods through carrying in luncheons and delivery of fruits and vegetables from the Mid-Ohio Food Bank.

Salvation Army Any age group or status that comes to our building seeking assistance or help. Clients are nearly all living 150% below the federal poverty level. Age is usually older than 18, any gender, new and existing clients. We served 1,328 with food, clothing vouchers, rent, utilities, and counseling.

United Way's Ross County CASH Coalition's Tax Prep. Program/Financial Awareness: Prepared free taxes for 1,354 Ross County residents bringing over 1.5 million dollars back to the community. Community partners were Ross County Community Action, and Southern Ohio Legal Aid.

Military Vets Resource Center: 220 Veterans were served. 33 received employment placements. 91 Veterans helped with shelter, transportation. 100% received nutrition assistance of food. 77% gained or maintain stable housing. 80% maintain employment with reliable transportation. 61% received mental health care. 88% improved financial self-sufficiency. 49% improved in job readiness. 62% received physical and dental care and education.

Wee Care Bundle of Joy

We successfully served approximately 95 different families with their varieties of baby needs.

Carver Community Center—Daily Meals- 1847 clients served. 79% of our clients received additional assistance through referrals, monthly health fairs or information sessions. 65% of our clients attend a monthly fair. 79% increased knowledge of services provided throughout the community.
